As Ventura County Medi-Cal beneficiaries, if you think you are or a family member needs substance use services, call the Beneficiary Access Line at **(844) 385-9200** (toll-free). The Access Team will perform a screening and referral to a DMC-ODS Plan provider, who will perform an assessment to determine medical necessity based on American Society of Addiction Medicine (ASAM) criteria. If necessary, the Access Line provides authorization for residential treatment. The following provider list includes both County operated and contracted providers.

- **Providers have the ability to provide culturally and linguistically appropriate treatment.**
- **Interpreter Services will be provided at no cost to you.**
- **All facilities have accommodations for people with physical disabilities.**
- **All Providers are accepting new beneficiaries.**
